

**NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES**

Veteran Dogs — For dogs over 7 years of age.

Veteran Bitches — For bitches over 7 years of age.

**BEST OF BREED (VARIETY) COMPETITION**

**Best of Breed (Variety) Competition** — The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by The American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

**NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES**

**Stud Dog Class** — For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

**Brood Bitch Class** — For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this will be based on the merit of more than one dog or bitch. No one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

**Brace Class** — Two dogs of the same breed with identical ownership & both dogs must be entered in a regular class.

**Team Class** — Four dogs of the same breed with identical ownership & all dogs must be entered in a regular class.

NOTICE TO EXHIBITORS — ADDITIONAL RULES

1. Owners or owner's agent are responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class for which it is not eligible. Entry fee(s) will not be refunded in the event of errors or cancellations received after the close of entries, nor in the event that a dog is absent, in season, disqualified, excused by Judge or Veterinarian, or barred from competition by action of the Show Committee.
2. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show and/or trial, no refund of entry fee(s) will be made.
3. This is an unbenchd show. Exhibitors need be present at scheduled judging time and, unless needed for further judging, may be excused immediately after being judged. Dogs MUST compete in every class in which they are entered or for which they become eligible.
4. Dogs must be ready for judging; owners or owner's agents are solely responsible for the presence of their dogs in the judging ring at the proper time. The Club and/or the Show Secretary will not be responsible for and are not obligated to provide any service for notifying exhibitors of breed or class judging. Judges will not wait for dogs holding up their rings.
5. The management will not be responsible for the loss or damage to any dogs, on or off of the showgrounds, whether the result of accident or any other cause. It is to be distinctly understood by all exhibitors that their dogs are to be in their custody and care at all times and that the dog's welfare is their sole responsibility.
6. The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.
7. There will be NO exercise pens, crates, tents or grooming tables allowed in the aisles adjacent to the judging rings. All grooming must be done in areas specified by the Club.
8. Trophies and other Prizes will be awarded in the judging rings unless otherwise specified by the Club. All claims for Trophies and other Prizes must be made in the judging ring before completion of judging by the person handling the dog; such person shall be considered as the owner or the owner's agent. The Secretary's Office is to be notified at once in the event of any discrepancies.
9. There is no provision for unentered dogs at this show. Chapter 15, Section 12 of AKC Rules and Regulations Applying to Registration and Dog Shows will be enforced.
10. A Recording Fee of 25 cents will be required for each dog entered at a Licensed or Member Club Show, Obedience Trial or Tracking Test. This Recording Fee is to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rules, Chapter 15, Section 2)



# SWEEPSTAKES

The Schipperke Club of Southern California Sweepstakes is open to all registered Schipperkes between the ages of 6 and 18 months. Sweepstakes will be judged prior to the judging of the regular classes and all entries in Sweepstakes MUST ALSO be entered in a Regular Class. Entry Fee for Sweepstakes shall be \$5.00 for each puppy and shall be marked in the space "Additional Class" on the entry blank by writing Sweepstakes and either 6 - 9, 9 - 12, or 12 - 18.

## Judging

The winner of 1st place in each Sweepstakes class is then eligible to compete for Best In Sweepstakes. After Best is chosen, those of the same sex as Best in Sweepstakes will be excused, and those remaining will compete for Best of Opposite to Best in Sweepstakes.

## Prize Distribution

Sweepstakes money will be divided as follows:

20% of all entry money will be retained by the Schipperke Club of Southern California to defray expenses.

20% of all entry money will be divided 60% to be awarded to Best In Sweepstakes and 40% to be awarded to Best of Opposite to Best In Sweepstakes. Remainder to be divided as follows:
