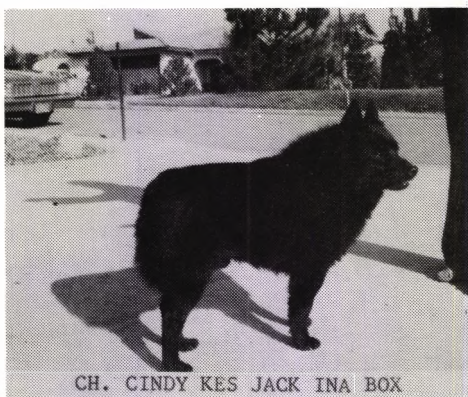

NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

VETERAN DOG CLASS -- For Dogs seven (7) years of age or older.

VETERAN BITCH CLASS -- For Bitches seven (7) years of age or older.

BEST OF BREED COMPETITION -- The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record; dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records.

NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES

STUD DOG CLASS -- For dogs that have sired at least two dogs or bitches entered at this show. The award will be based on the merits of the get. The Stud Dog must appear in the ring with at least two, but not more than six, of his get, and must be entered in the Stud Dog Class. Each of the get must be individually entered in one of the Regular Classes, Best of Breed Competition or some Non-Regular Class other than Stud Dog Class of the Specialty Show. The owner of the Stud Dog need not necessarily be the owner of the get.

BROOD BITCH CLASS -- For bitches that have produced at least two dogs or bitches entered at this show. The award will be based on the merits of the produce. The Brood Bitch must appear in the ring with at least two, but not more than six, of her produce, and must be entered in the Brood Bitch Class. Each of the produce must be individually entered in one of the Regular Classes, Best of Breed Competition, or some Non-Regular Class other than Brood Bitch Class of the Specialty Show. The owner of the Brood Bitch need not necessarily be the owner of the produce.

CLASSIFICATION -- SPECIALTY SHOW (cont.)

BRACE CLASS -- For two dogs of the same breed or variety irrespective of sex, with identical ownership. Identical ownership means that owner and co-owner(s) must be the same for both dogs. The dogs comprising a Brace must be named at time of entry. If a dog which is to be part of a Brace is not entered in another class, it must be entered "For Brace Class Only" at the regular entry fee, and full particulars given on an individual regular entry form. An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for Additional Classes -- "Brace Class." For a Brace comprised of two dogs who are each entered in other classes, the fee for the Brace as a Unit is the Additional Class Entry Fee.

TEAM CLASS -- For four dogs of the same breed or variety irrespective of sex, with identical ownership. Identical ownership means that owner and co-owner(s) must be the same for all four dogs. The same rules as for Brace Class (above) will apply.

As the judge's decision in the Stud Dog, Brood Bitch, Brace and Team Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won one or more of these classes.

SWEEPSTAKES

RULES AND CONDITIONS

1. Sweepstakes Entry Fee: \$5.00.
2. All Sweepstakes entries must also be entered in a regular class at the regular entry fee. Entry to me made at the same time as entry in a regular class, and on the same entry form as the regular class entry, and marked "SWEEPSTAKES", with class division shown, in the Additional Class space on the entry form.
3. The Sweepstakes is open to all Schipperke puppies who on the day of the show will be 6 months old and under 18 months old. Champions are not excluded from Sweepstakes competition, provided they meet all other eligibility requirements.

SWEEPSTAKES -- RULES AND CONDITIONS (cont.)

4. Classes are divided by age and sex, in the following Class Divisions: (BE SURE TO ENTER ONE OF THESE ON THE ENTRY FORM)

PUPPY DOG -- for dogs 6 mos. and under 9 mos. of age.
JUNIOR DOG -- for dogs 9 mos. and under 12 mos. of age.
SENIOR DOG -- for dogs 12 mos. and under 18 mos. of age.
PUPPY BITCH -- for bitches 6 mos. and under 9 mos. of age.
JUNIOR BITCH -- for bitches 9 mos. and under 12 mos. of age.
SENIOR BITCH -- for bitches 12 mos. and under 18 mos. of age.

5. The six Class winners will compete for Best in Sweepstakes.
6. The Sweepstakes will be judged prior to the Specialty Show.

SWEEPSTAKES PRIZES

Sweepstakes Prize Money shall be divided as follows: (the Club will deduct 20% of entry fees to help defray expenses)

20% of all entry money will be divided, 60% to be awarded to Best in Sweepstakes and 40% to be awarded to Best of Opposite Sex to Best in Sweepstakes. Remainder to be divided as follows:

JUNIOR SHOWMANSHIP COMPETITION

CLASS DEFINITIONS AND RULES

NOVICE JUNIOR CLASS -- For Boys and Girls who are at least 10 years old and under 13 years old on the day of the show and who, at the time entries close, have not won three First Places in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS -- For Boys and Girls who are at least 13 years old and under 17 years old on the day of the show and who, at the time entries close, have not won three First Places in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS -- For Boys and Girls who are at least 10 years old and under 13 years old on the day of the show and who, at the time entries close, have won three First Places in a Novice Junior Showmanship Class at a licensed or member show.

OPEN SENIOR CLASS -- For Boys and Girls who are at least 13 years old and under 17 years old on the day of the show and who, at the time entries close, have won three First Places in a Novice Junior Showmanship Class at a licensed or member show.

BEST JUNIOR HANDLER -- The winner of each class shall compete for Best Junior Handler.

Each dog handled in a regular Junior Showmanship Class must be entered and shown in one of the Breed Classes at the show, or must be entered for Junior Showmanship Only. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or Obedience Trials. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

The winner of a third First Place in each Novice Class shall automatically become eligible to enter in the corresponding Open Class at this show, provided that there are one or more Junior Handlers competing in that Open Class.

Winning of First Place in an Open Junior Showmanship Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC, write to The American Kennel Club, Show Plans, 51 Madison Ave., New York, NY 10010.

The Champion Parade will be held following the regular judging, to be announced in the Judging Program and at the Show.

NOTICE TO EXHIBITORS

1. Entries accompanied by the required fees must be received by the Show Secretary, Mrs. Mildred Van Cleve, 3213 N. Athol St., Baldwin Park, CA 91706, NO LATER THAN 6:00 PM, WEDNESDAY, JAN. 12, 1983, after which time no entries may be accepted, cancelled, changed, substituted, corrected, completed or signed and no entry fees refunded. Class changes and cancellations must be in writing and must be received prior to closing. Telephone changes and cancellations are not acceptable. Entries not on official American Kennel Club entry forms, or on photocopies of AKC entry forms without the agreement on the reverse side are not acceptable. This Club and/or its Show Secretary assume no responsibility for wrong or incomplete information given on the entry form by the owner or the owner's agent, for entering the same dog twice, or for entering a dog in a class in which it is not eligible to compete.
2. Exhibitors identification tickets and judging programs will be mailed to the address given on the entry form, not later than one week prior to the day of the show. If not received within a reasonable time after that, contact the Show Secretary.
3. There is NO provision at this show for unentered dogs, and unentered dogs will not be allowed on the show premises.
4. Dogs need be at the show only at the scheduled time of judging and will be excused when no longer needed for further judging. During judging hours, owners or agents are to be on call, and have their dogs ready to bring into the judging ring promptly. It is the responsibility of the exhibitor to have the dog ready to be shown and at the entrance to the judging ring when the class is called. There is no rule of The American Kennel Club or this Club that requires a judge to wait for owner or handler to bring the dog into the judging ring.
5. Trophies and prizes will be awarded in the judging ring to the person exhibiting the dog, who will be considered as the owner or the owner's agent. All claims for trophies or prizes must be made in the judging ring prior to the completion of judging, and the Show Secretary advised at once of any discrepancy.
6. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Show Committee, or because the dog is ineligible to compete due to being entered incorrectly, or for duplicate entry of the same dog.
7. If, because of riots, civil disturbances, or other acts beyond control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.
8. The Schipperke Club of Southern California may decline any entries for cause, and may refuse to receive or may remove any dog on account of disease, viciousness, or for other causes, and no one shall have any recourse or claim against the Club or any official thereof.
9. The Club and/or its Show Secretary will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes. It is distinctly understood that every dog at the show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises.
10. Exhibitors are advised to become familiar with the agreement of The American Kennel Club on the reverse side of the entry form that accompanies this Premium List.
