## AMERICAN KENNEL CLUB SCHEDULE OF POINTS

Division 9 - State of California - Effective May 15, 1990

The Points toward a Championship shall be awarded to the Winners Dog and Winners Bitch. Only dogs entered and judged in the Regular Classes will be counted as being present for the purpose of Championship rating.

Any dog which shall have won fifteen points shall become a Champion of Record, if six or more points shall have been won at two shows with a rating of 3 or more Championship Points each and under two different judges, and some one or more of the balance of the points shall have been won under some other judge or judges that the two judges referred to above.

Dogs competing to obtain ratings below - Scale of Points:

<u>SCHIPPERKES</u>	<u>1</u>	<u>2</u>	<u>3</u>	<u>4</u>	<u>5</u>
Dogs	2	4	7	9	14
Bitches	2	5	8	10	14

### OBEDIENCE TRIAL CHAMPIONSHIP

Championship Points will be recorded only for those dogs which have earned Utility Dog Title. Championship Points will be recorded for those dogs which have earned a First or Second Place ribbon competing in the Open B or Utility B Class.

Requirements for the Obedience Trial Championship are as follows:

1. Shall have won 100 points; and
2. shall have won a First Place in Utility B provided there are at least three dogs in competition; and
3. shall have won a First Place in Open B provided there are at least six dogs in competition; and
4. shall have won a third First under the conditions of 2 or 3 above; and
5. shall have won these three First Places under three different judges.

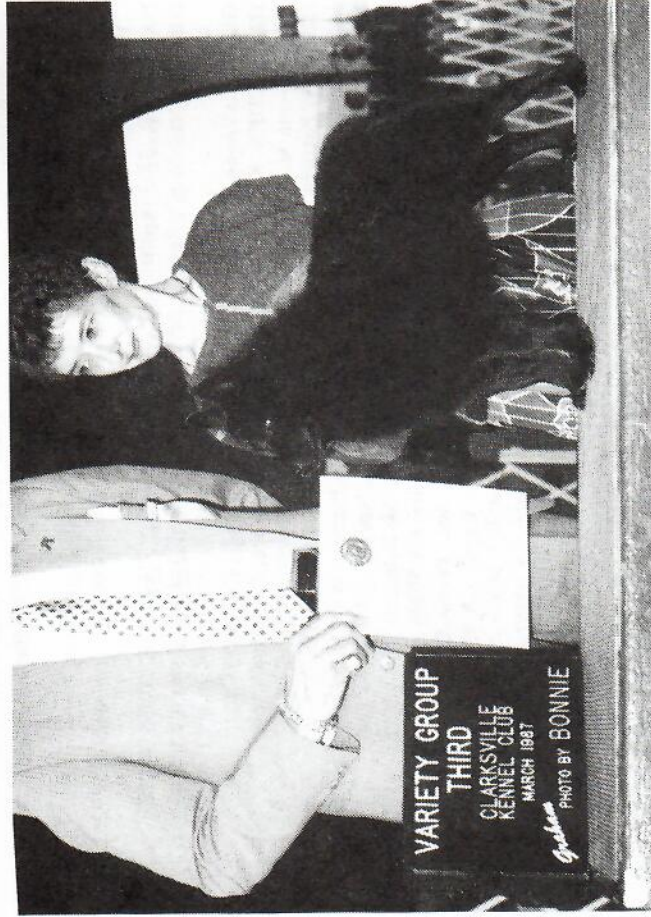

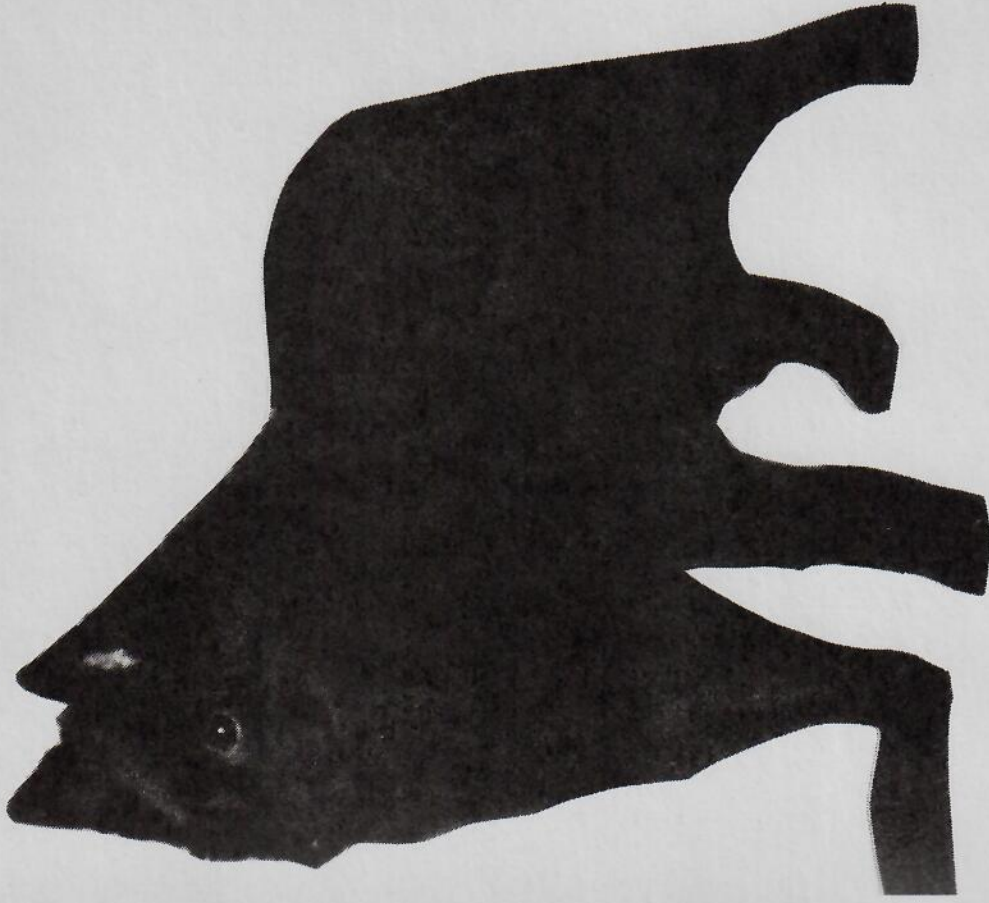
