

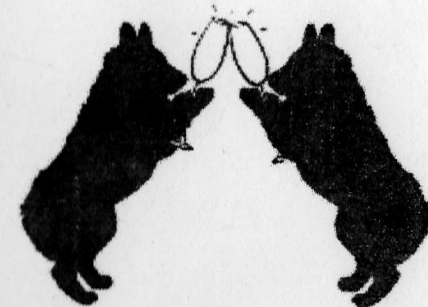

## CHALLENGE TROPHIES

**THE FOLLOWING CHALLENGE TROPHIES WILL BE OFFERED AT THE MORNING SPECIALTY AND THEN AT THE AFTERNOON SPECIALTY UNLESS ANY OF THE TROPHIES ARE RETIRED AT THE MORNING SHOW, IN WHICH CASE IT WILL NOT BE OFFERED/AVAILABLE FOR THE AFTERNOON SHOW.**

- BEST OF BREED** - Members of SCSC offer a challenge trophy. For permanent possession, the trophy must be won three times by the exact same owner(s), not necessarily with the same dog nor at consecutive shows. The trophy is a decorative glass block with an etched Schipperke silhouette sitting atop a lighted wooden base. It will be adorned with a brass plate on which the year, dog's name and owner's name are to be engraved. It is to remain in the possession of the Club until it is retired. A token trophy will be offered by SCSC.
- BEST OF OPPOSITE SEX TO BEST OF BREED** - Members of SCSC offer a challenge trophy. For permanent possession, the trophy must be won three times by the exact same owner(s), not necessarily with the same dog nor at consecutive shows. The trophy is a Silver-Plated Candelabra. It will be adorned with a brass plate on which the year, dog's name and owner's name are to be engraved. It is to remain in the possession of the Club until it is retired. A Candle Holder will be offered by SCSC as a token trophy.
- BEST IN PUPPY SWEEPSTAKES, BEST OF BREED, HIGH IN TRIAL** - Daniel J. Meininger, Arleen T. Meininger & Barbara Guerini offer the "Ch. Coal Creek's Artful Dodger CD, CGC" Challenge Trophy. For permanent possession, the same dog or bitch must win Best in Puppy Sweepstakes, Best of Breed and High in Trial (all 3) at the Schipperke Club of Southern California's annual show, not necessarily with the same owner. The trophy is an ornate champagne cooler mounted on a mahogany wood base adorned with a silver plate engraved with the following: Ch. Coal Creek's Artful Dodger CD, CGC's Challenge Trophy, In memory of Ch. Coal Creek's Keeley, Best Puppy in Sweepstakes, Best of Breed, High in Trial. It is to remain in the possession of the Club until it is retired.

- BEST OF OPPOSITE SEX TO BEST IN PUPPY SWEEPSTAKES** - Members of SCSC offer a challenge trophy. It is to remain in the possession of the Club until it is retired. A small token trophy will be offered by SCSC.
- BEST OF OPPOSITE SEX TO BEST IN VETERAN SWEEPSTAKES** - Members of SCSC offer a challenge trophy. For permanent possession, the trophy must be won three times by the exact same owner(s), not necessarily with the same dog nor at consecutive shows. It is a silver-plated serving dish. It is to remain in the possession of the Club until it is retired. A small token trophy will be offered by SCSC.

**SWEEPSTAKES COMPETITION - OFFERED AT THE AFTERNOON SPECIALTY ONLY  
PUPPY SWEEPSTAKES**

This Sweepstakes is open to all Schipperkes at least 6 months and under 18 months of age on the day of the show. Dogs who have completed their Championship are eligible to compete. The winner of each class will compete for Best in Puppy Sweepstakes and Best of Opposite Sex in Puppy Sweepstakes. All entries in Puppy Sweepstakes must also be entered in a regular class in this show. Entries shall be made at the same time on the same entry form used for the regular class. Indicate "Puppy Sweepstakes" and the appropriate sex and age in the space provided for Additional Classes.

The Following Age Division Classes Are Offered for Both Dogs and Bitches:  
6 months & under 9 months      9 months & under 12 months      12 months & under 18 months

**VETERAN SWEEPSTAKES**

This Sweepstakes is open to all Schipperkes 7 years of age and over on the day of the show. Neutered dogs and spayed bitches may be entered in this class. The winner of each class will compete for Best in Veteran Sweepstakes and Best of Opposite Sex in Veteran Sweepstakes. Entries in Veteran Sweepstakes need not be entered in any other class at this show. Entries shall be made at the same time on the same entry form used for the regular classes. Indicate "Veteran Sweepstakes" and the appropriate sex and age in the space provided for Additional Classes.

The Following Age Division Classes Are Offered for Both Dogs and Bitches:  
7 years and under 10 years      10 years and under 12 years      12 years and older

**DIVISION OF PRIZE MONEY FOR PUPPY & VETERAN SWEEPSTAKES**

All monies from entry fees will be divided as follows:

5% of monies received to be withheld for SCSC expenses.

25% of monies received will be divided as follows: • Best - 60% • Best of Opposite Sex - 40%

70% of the remaining monies received will be divided as follows:

- Classes having four or more entries      First - 40%, Second - 30%, Third - 20%, Fourth - 10%.
- Classes having three entries      First - 50%, Second - 30%, Third - 20%.
- Classes having two entries      First - 60%, Second - 40%.
- Classes having one entry      First - 100%.

**JUNIOR SHOWMANSHIP COMPETITION**

**NOVICE CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

Each dog handled in a regular Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitution must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in AKC Dog Shows or Obedience Trials. Bitches in season are not eligible to compete.

Junior Handlers who win a third Novice Class, with competition present, after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent /Event Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes, which have been approved to date by AKC, write to the American Kennel Club, Show Plans, 5580 Centerview Dr., Suite 200, Raleigh, NC 27606.

Junior Handlers must include their AKC Junior Handler Identification number on the entry blank. You may obtain your number by calling the AKC (919) 816-3776, email: juniors@akc.org.

Each dog entered must be of the breed for which this show is held.

Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form. By signing the entry form certification is given that the Junior Showman does not now, and will not at any time act as an agent/handler for pay while continuing to compete in Junior Showmanship.

Championship points will be recorded for those dogs which have earned a First, Second, Third or Fourth place ribbon competing in the Open B or Utility B Class according to the schedule of points established by the Board of Directors of the American Kennel Club. In counting the number of eligible dogs in competition, a dog that is disqualified or is excused from the ring by the judge will not be included. Requirements for the Obedience Trail Champion are:

The dog must have won:

1. 100 points
2. A first place in Utility B with at least three dogs in competition.
3. A first place in Open B with at least six dogs in competition.
4. An additional first place under the conditions of 2 or 3 above.
5. All three first places under three different judges. One of the required first places may have been won at a Specialty Show.

## AKC SCHIPPERKE BREED STANDARD

**General Appearance** - The Schipperke is an agile, active watchdog and hunter of vermin. In appearance he is a small, thickset, cobby, black, tailless dog, with a fox-like face. The dog is square in profile and possesses a distinctive coat, which includes a stand-out ruff, cape and culottes. All of these create a unique silhouette, appearing to slope from shoulders to croup. Males are decidedly masculine without coarseness. Bitches are decidedly feminine without overrefinement. Any deviation from the ideal described in the standard should be penalized to the extent of the deviation. Faults common to all breeds are as undesirable in the Schipperke as in any other breed, even though such faults may not be specifically mentioned in the standard.



**Size, Proportion, Substance** - **Size**--The suggested height at the highest point of the withers is 11-13 inches for males and 10-12 inches for bitches. Quality should always take precedence over size. **Proportion**--Square in profile. **Substance**--Thickset.

**Head** - **Expression**--The expression is questioning, mischievous, impudent and alert, but never mean or wild. The well proportioned head, accompanied by the correct eyes and ears, will give the dog proper Schipperke expression. **Skull**--The skull is of medium width, narrowing toward the muzzle. Seen in profile with the ears laid back, the skull is slightly rounded. The upper jaw is moderately filled in under the eyes, so that, when viewed from above, the head forms a wedge tapering smoothly from the back of the skull to the tip of the nose. The stop is definite but not prominent. The length of the muzzle is slightly less than the length of the skull.

**Eyes** - The ideal eyes are small, oval rather than round, dark brown, and placed forward on the head.

**Ears**--The ears are small, triangular, placed high on the head, and, when at attention, very erect. A drop ear or ears is a disqualification. **Nose**--The nose is small and black. **Bite**--The bite must be scissors or level. Any deviation is to be severely penalized.

**Neck, Topline, Body** - **Neck**--The neck is of moderate length, slightly arched and in balance with the rest of the dog to give the correct silhouette. **Topline**--The topline is level or sloping slightly from the withers to the croup. The stand-out ruff adds to the slope, making the dog seem slightly higher at the shoulders than at the rump. **Body**--The chest is broad and deep, and reaches to the elbows. The well sprung ribs (modified oval) are wide behind the shoulders and taper to the sternum. The fore chest extends in front of the shoulders between the front legs. The loin is short, muscular and moderately drawn up. The croup is broad and well-rounded with the tail docked. No tail is visually discernible.

**Forequarters** - The shoulders are well laid back, with the legs extending straight down from the body when viewed from the front. From the side, legs are placed well under the body. Pasterns are short, thick and strong, but still flexible, showing a slight angle when viewed from the side. Dewclaws are generally removed. Feet are small, round and tight. Nails are short, strong and black.

**Hindquarters** - The hindquarters appear slightly lighter than the forequarters, but are well muscled, and in balance with the front. The hocks are well let down and the stifles are well bent. Extreme angulation is to be penalized. From the rear, the legs extend straight down from the hip through the hock to the feet. Dewclaws must be removed.

**Coat** - **Pattern**--The adult coat is highly characteristic and must include several distinct lengths growing naturally in a specific pattern. The coat is short on the face, ears, front of the forelegs and on the hocks; it is medium length on the body, and longer in the ruff, cape, jabot and culottes. The ruff begins in back of the ears and extends completely around the neck; the cape forms an additional distinct layer extending beyond the ruff; the jabot extends across the chest and down between the front legs. The hair down the middle of the back, starting just behind the cape and continuing over the rump, lies flat. It is slightly shorter than the cape but longer than the hair on the sides of the body and sides of the legs. The coat on the rear of the thighs forms culottes, which should be as long as the ruff. Lack of differentiation in coat lengths should be heavily penalized, as it is an essential breed characteristic. **Texture**--The coat is abundant, straight and slightly harsh to the touch. The softer undercoat is dense and short on the body and is very dense around the neck, making the ruff stand out. Silky coats, body coats over three inches in length or very short harsh coats are equally incorrect. **Trimming**--As the Schipperke is a natural breed, only trimming of the whiskers and the hair between the pads of the feet is optional. Any other trimming must not be done.

**Color** - The outer coat must be black. Any color other than a natural black is a disqualification. The undercoat, however, may be slightly lighter. During the shedding period, the coat might take on a transitory reddish cast, which is to be penalized to the degree that it detracts from the overall black appearance of the dog. Graying due to age (seven years or older) or occasional white hairs should not be penalized.

**Gait** - Proper Schipperke movement is a smooth, well coordinated and graceful trot (basically double tracking at a moderate speed), with a tendency to gradually converge toward the center of balance beneath the dog as speed increases. Front and rear must be in perfect balance with good reach in front and drive in the rear. The topline remains level or slightly sloping downward from the shoulders to the rump. Viewed from the front, the elbows remain close to the body. The legs form a straight line from the shoulders through the elbows to the toes, with the feet pointing straight ahead. From the rear, the legs form a straight line from the hip through the hocks to the pads, with the feet pointing straight ahead.

**Temperament** - The Schipperke is curious, interested in everything around him, and is an excellent and faithful little watchdog. He is reserved with strangers and ready to protect his family and property if necessary. He displays a confident and independent personality, reflecting the breed's original purpose as watchdog and hunter of vermin.

**Disqualification** - A drop ear or ears. Any color other than a natural black.

## ADDITIONAL RULES

1. Entries must reach the Show Secretary, Sharon Licciardi, 38512 12th St E, Palmdale, CA 93550, by NOON (PST) WEDNESDAY, JANUARY 13, 2010. Fees should accompany entries. This club and/or its secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its secretary assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned checks do not constitute a valid entry fee. The club will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check must be made good by cash or money order before the dog will be allowed in the ring.
3. Exhibitors' identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the secretary. Tickets returned by the Post Office marked 'undeliverable' will be held by the Secretary.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The AKC that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 8am-8pm.
5. Trophies and prizes will be awarded in the judging rings to the person exhibiting the dog, who is considered to be the owner or agent of the owner. All claims for trophies and prizes must be made in the judging ring before the completion of judging the breed. Notify the secretary of any discrepancy. No trophies or prizes will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available at the Secretary's table at the show or may be obtained from the AKC, 5580 Centerview Dr. #200, Raleigh, NC 27606.
7. The club, its secretary or their employees will not be responsible for the loss or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club.
9. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry.
10. There is no provision offered for un-entered dogs at this show.
11. Declination of Entries. The Southern California Schipperke Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles. All persons attending this dog show hereby waive any claim for damages against the Southern California Schipperke Club, its members or agents, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
14. A Recording Fee of 50¢ and an Event Service Fee of \$1.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the Recording Fee and Event Service Fee are to be collected on the first entry only (AKC Rule, Chapter 11, Section 2).
15. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed Competition, provided this transfer is made by the Secretary at least one half hour prior to the start of the earliest Conformation judging at the Show.
16. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made to the Secretary at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
17. All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the Club. All persons and animals on the show grounds at anytime while the show is in progress, do by attending this show or participating therein, grant to the club the right to photograph, televise, video tape, audiotape or otherwise use their likeness and voice in any manner without further release or consent.
18. The club is not responsible for the actions or products of the commercial vendors at this show.
19. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the secretary at least 30 minutes prior to the start of each trial.
20. The Club reserves the right to substitute a prize of equal or greater value.
21. There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises.
22. All dogs shall be kept on leash except when in the obedience or exercising ring or confined in crates.
23. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.
