## **Betty Witt**

Betty was a war bride in the 40's marrying American G.I. Bob Witt and moving with him to America. They and two children Pam and Robert.

On a visit back to Australia she was introduced to Schipperkes by seeing hr sister Peg Bills first Schipp. - blue (Peg later became a breeder of "Pocher" French Bulldogs and Schipps). Like many others, Betty developed a life-long passion for the breed.

She acquired 3 Schipperkes from Roy and Carol Henry's "Jet-O" Kennels in the U.S.A.

"Black Power Of Jet-O" (D)

"Maid Special Of Jet-O" (B)

"Little Cuddler Of Jet-O" (B)

In the late 1900's Bob and Betty moved back to Australia to care for

Betty's mother, bringing the 3 Schipperkes with them. (However, the dogs had to do 2 years of quarantine in England before being allowed into Australia.) During this time Peg and Betty ran a second hand shop in Melbourne to pay for the dogs quarantine expenses. Betty also worked as a food demonstrator and she and Bob later also operated a Laundromat.

When the dogs were finally out of quarantine, Betty became an enthusiastic dog exhibitor, winning many major Breed Awards with her American Schipps.

Like her dogs, she was always beautifully presented. She stood out from the crowd looking immaculate in her coordinated out-fits and hats and her American "twang" - her catch phrase around the show ring of "How About Them Apples" was unforgettable.

Betty registered the prefix "Jet-O" in Australia and bred several "Australian Champions" during her time here.

After her mother's death, Bob and Betty moved back to the U.S.A. permanently as their adult children still lived there. They took 4 dogs with them, 2 of the original Schipps (Little Cuddler Of Jet-O" stayed in Australia with Peg) and 2 of their Australian bred bitches.

In the U.S.A. Betty registered her prefix as "Jet-All". ("Jet-O" was already the Henry's prefix.)

Residing in California, Betty became a major exhibitor and breeder with her "Jet-All" Schipperkes in the 1980's and 1990's. She went on to breed many American Champions.

During this time, she specifically bred a male for hr sister Peg in Australia - Aust Ch Jet-All Hustler II of Pocher (Imp USA). "Hustler" was 3 years in production, but well worth the wait! His descendants are still taking top honors in Australian show-rings.

Betty was also a talented artist, and during the 1980's she donated hand painted Schipperke plates for B.O.B. at Melbourne Royals. Luckily, I had the privilege of winning 4 of her lovely plates.

Peg visited Betty often in the States and together they attended 6 American Schipperke Specialty Shows. Huge affairs held in Hotels/Convention Centres. During one visit they organized frozen semen to be sent to Australia, with Betty offering suggestions for names of the resulting progeny "Simon Sez", "Dixie Chick" and "Secret Agent" were all named by Betty.

After Bob died, Betty moved to Arkansas to live with her daughter Pam, taking her last 3 dogs with her. She kept up an active interest in Schipperkes and shows for several years. Even after moving into a care home, Betty was still keen in hearing about "Skippy" news.

Not too many breeders have produced continual top winning Champions, over several generations, in 2 different countries - But Betty did!

The majority of present day Australian Schipperke enthusiasts never met Betty Witt. However, her dedication to the Breed contributed to the improvement of Schipperkes in both Australia and the U.S.A. We all have a lot to be grateful for.

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class. Each dog handled in a regular Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitution must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in AKC Dog Shows or Obedience Trials. Bitches in season are not eligible to compete.

Junior Handlers who win a third Novice Class, with competition present, after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent /Event Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. - Entries must reach the Show Secretary, Sharon Licciardi, 38512 12th St E, Palmdale, CA 93550, by NOON (PST) WEDNESDAY, January 12, 2011. Fees should accompany entries. This club and/or its secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its secretary assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
- Returned checks do not constitute a valid entry fee. The club will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check must be made good by cash or money order before the dog will be allowed in the ring.
- Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the secretary. Tickets returned by the Post Office marked 'undeliverable' will be held by the Secretary.
- During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The AKC that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 8am-8pm.
- Trophies and prizes will be awarded in the judging rings to the person exhibiting the dog, who is considered to be the owner or agent of the owner. All claims for trophies and prizes must be made in the judging ring before the completion of judging the breed. Notify the secretary of any discrepancy. No trophies or prizes will be mailed.
- Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available at the Secretary's table at the show or may be obtained from the AKC, 5580 Centerview Dr. #200, Raleigh, NC 27606.
- The club, its secretary or their employees will not be responsible for the loss or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show
- No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done away from the judging ring in
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry.
- 10. There is no provision offered for un-entered dogs at this show.
- Declination of Entries. The Southern California Schipperke Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
- If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
- Do not leave any dogs in closed vehicles. All persons attending this dog show hereby waive any claim for damages against the Southern California Schipperke Club, its members or agents, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation
- 14. A Recording Fee of 50¢ and a Event Service Fee of \$1.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the Recording Fee and Event Service Fee are to be collected on the first entry only (AKC Rule, Chapter 11, Section 2).
- Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed Competition, provided this transfer is made by the Secretary at least one half hour prior to the start of the earliest Conformation judging at the Show.
- Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made to the Secretary at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the Club. All persons and animals on the show grounds at anytime while the show is in progress, do by attending this show or participating therein, grant to the club the right to photograph, televise, video tape, audiotape or otherwise use their likeness and voice in any manner without further release or consent.
- The club is not responsible for the actions or products of the commercial vendors at this show.
- Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the secretary at least 30 minutes prior to the start of each trial.
- 20. The Club reserves the right to substitute a prize of equal or greater value.
- 21. There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises.
- All dogs shall be kept on leash except when in the obedience or exercising ring or confined in crates.
- The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.
