### CHALLENGE TROPHY

BEST OF BREED - Kristen Henry, Bonchien Schipperkes, offers the GCHG Cedric The Entertainer HOF Memorial Challenge Trophy. For permanent possession, the trophy must be won three times by the exact same owner(s), not necessarily with the same dog nor at consecutive shows. The trophy is a wooden plaque adorned with a picture of GCHG Cedric The Entertainer HOF. The trophy will be engraved above the picture with the following: "Best of Breed-GCHG Cedric The Entertainer HOF Memorial Challenge Trophy-SCSC." After each Specialty, it will be adorned with a plate on which the year, BOB dog's name and owner's name(s) are to be engraved. A token trophy will be offered by SCSC.

### AWARD OF MERIT

A Judge may, at his/her discretion, present an Award of Merit to those quality dogs he/she feels are worthy of final consideration in Best of Breed. Award of Merit winners will receive a three-streamer rosette in Belgian colors of black, yellow & red. The number of these awards is determined by the number of dogs actually competing in the ring (excluding Select Dog and Select Bitch):

**Regulations**

**Section 1- Classifications**

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

**Section 2 – Entry and Eligibility**

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form, and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class but must be handled by a non-professional handler. *Professional handlers are defined as a person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

**ADDITIONAL RULES**

1. Entries must reach the Superintendent, Jack Bradshaw, 320 Maple Avenue, Torrance, CA 90503, by Noon, Wednesday January 12, 2022 PT. Fees should accompany entries. These clubs and their Superintendents assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agents of the owner. These clubs and its Superintendents assume no responsibility for entry by the owner or owners agents of a dog in a class in which the dog is not eligible to compete or for entering the same dog twice.
2. Returned checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check must be made good by cash or money order before the dog will be allowed in the ring.
3. Exhibitors' identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. Bring your identification tickets to the show.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly in order that the judge will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. It is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7:00 a.m. to 8:00 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the Superintendent's office should be advised at once in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at [www.akc.org](http://www.akc.org)
7. The club, its Superintendents and their employees will not be responsible for loss of or damage to any dog exhibited, whether as the result of accident or for any other cause and no responsibility is assumed for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises.
8. No crates, crates with carts, grooming tables, nor exercise pens will be allowed in the aisles. Setups, crates, equipment, etc. are to be in designated areas only, except as otherwise specifically authorized by the Show Chair, and will not be allowed in any other areas.
9. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of any entry fee for a duplicate entry. There will be a \$4.00 fee charged for cancellation of an entry prior to closing of entries.
10. There is no provision offered for un-entered dogs at this show.
11. Declination of Entries. The Schipperke Club of Southern California may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Clubs or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of these clubs, or management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half-hour prior to the start of the earliest conformation judging at the show.
15. Junior Handlers who win a third Novice Class after the closing of entries may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.
16. No alcohol is allowed on the grounds.
17. No practicing is allowed in the rings at any time.
18. Parents and/or guardians are responsible for the actions of their children.
19. By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present and agree not to hold the superintendent liable for any illness or injury.
20. By attending this event, you voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Jack Bradshaw Dog Shows, its owners, employees or volunteers liable for any illness or injury.
