For boys and girls who are at least 14 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

#### Open Junior Class

For boys and girls who are at least 10 years old and under 14 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

#### Open Senior Class

For boys and girls who are at least 14 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Each dog handled in a regular Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog that must be withdrawn for good and sufficient reason, such as a Bitch in Season, or a Veterinarian's excuse, may be replaced by another dog meeting the below ownership requirements. Such substitution must be requested in writing stating the reason for the substitution and must be accompanied by an official AKC entry form. All such requests must be made one half-hour prior to the judging of any regular classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

Junior Handlers who win a third Novice Class, with competition present, after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent/Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Junior Handlers must include their AKC Junior Handler identification number on the entry blank. You may obtain your number by calling the AKC Event Records Department at (212) 696-8281.

NOTICE: Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.





# SCHEDULE OF POINTS FOR DIVISION 9 (California) Effective May 14, 1996

The Points toward a Championship shall be awarded to the Winners Dog and Winners Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dogs or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dogs or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition and have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.


In counting the number od eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused, or orderedfrom the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won a two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.
