STUD DOG CLASS - For Stud Dogs and a minimum of two and maximum of three of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes. Or if a Champion of Record, in the Best of Breed Competition, but MUST be entered in the Stud Dog Class, the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS - Same as for the Stud Dog Class except substitute "Brood Bitch" for "Stud Dog" and "Produce" for "Get."

BRACE CLASS - Two dogs of the same Breed with identical ownerships. The dogs are not required to be entered in a regular class.

TEAM CLASS - Same as Brace Class, except substitute 4 dogs for 2 dogs.

SCHIPPERKES ON PARADE

Dogs entered in this class may or may not be entered in a regular class at this show. Dogs need not be holder of an AKC title. A Class Streamer Rosette with the dog's name will be awarded.

PARADE OF CASTAWAYS

Dogs entered in this class may or may not be entered in a regular class at this show. These dogs are Schipperkes of any age, with or without papers, who were obtained through adoption from an original owner, known or unknown, who couldn't or wouldn't keep them. A Class Streamer Rosette with the dog's name will be awarded.

SWEEPSTAKES COMPETITION

PUPPY SWEEPSTAKES

This Sweepstakes is open to all Schipperkes at least 6 months & under 18 months of age on the day of the show. Dogs who have completed their Championship are eligible to compete. The winner of each class will compete for Best in Puppy Sweepstakes and Best of Opposite Sex in Puppy Sweepstakes. All entries in Puppy Sweepstakes must also be entered in a regular class in this show.

The winner of each class will compete for Best in Veteran Sweepstakes and Best of Opposite Sex in Veteran Sweepstakes. Entries in Veteran Sweepstakes need not be entered in any other class at this show.

DIVISION OF PRIZE MONEY FOR PUPPY & VETERAN SWEEPSTAKES

All monies from entry fees will be divided as follows:

5% of monies received to be withheld for SCSC expenses.

25% of monies received will be divided as follows:

- Best in Sweepstakes - 60%
- Best of Opposite Sex to Best in Sweepstakes - 40%

70% of the remaining monies received will be divided as follows:

NOVICE JUNIOR CLASS: For boys & girls who are at least 10 yrs & under 14 yrs on the day of the show and who, at the time entries close, have not won 3 First Place awards with competition present in a Novice Class at a licensed/member show.

NOVICE SENIOR CLASS: For boys & girls who are at least 14 yrs & under 18 yrs on the day of the show and who, at the time entries close, have not won 3 First Place awards with competition present in a Novice Class at a licensed/member show.

OPEN JUNIOR CLASS: For boys & girls who are at least 10 yrs & under 14 yrs old on the day of the show and who, at the time entries close, have won 3 First Place awards with competition present in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS: For boys & girls who are at least 14 yrs & under 18 yrs old on the day of the show and who, at the time entries close, have won 3 First Place awards with competition present in a Novice Class at a licensed or member show.

Each dog handled in a regular Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitution must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in AKC Dog Shows or Obedience Trials. **Bitches in season are not eligible to compete.**

Junior Handlers who win a third Novice Class, with competition present, after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent /Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes, which have been approved to date by AKC, write to the American Kennel Club, Show Plans, 5580 Centerview Dr., Suite 200, Raleigh, NC 27606.

Junior Handlers must include their AKC Junior Handler Identification number on the entry blank. You may obtain your number by calling the AKC (919)854-0195.

Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form. By signing the entry form certification is given that the Junior Showman does not now, and will not at any time act as an agent/handler for pay while continuing to compete in Junior Showmanship.
