For complete Conformation Championship requirements, see Chapter 16 of the Rules Applying to Dog Shows.

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for it sex in calculating championship points

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

For schedule of points corresponding to this dog show, please see breed heading.

NOTICE: An agent is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner of an exhibit to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications which are available online at akc.org.

#### ADDITIONAL RULES

- 1. Entries must reach the Superintendent, Jack Bradshaw, 320 Maple Avenue, Torrance, CA 90503, by Noon, Wednesday January 10, 2024 PT. Fees should accompany entries. These clubs and their Superintendents assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agents of the owner. These clubs and its Superintendents assume no responsibility for entry by the owner or owners agents of a dog in a class in which the dog is not eligible to compete or for entering the same dog twice.
- Returned checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check must be made good by cash or money order before the dog will be allowed in the ring.
- 3. Exhibitors' identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. Bring your identification tickets to the show.
- 4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly in order that the judge will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. It is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7:00 a.m. to 8:00 p.m.
- 5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the Superintendent's office should be advised at once in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
- 6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at www.akc.org
- 7. The club, its Superintendents and their employees will not be responsible for loss of or damage to any dog exhibited, whether as the result of accident or for any other cause and no responsibility is assumed for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises.
- 8. No crates, crates with carts, grooming tables, nor exercise pens will be allowed in the aisles. Setups, crates, equipment, etc. are to be in designated areas only, except as otherwise specifically authorized by the Show Chair, and will not be allowed in any other areas.
- 9. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of any entry fee for a duplicate entry. There will be a \$4.00 fee charged for cancellation of an entry prior to closing of entries.
- 10. There is no provision offered for un-entered dogs at this show.
- 11. Declination of Entries. The Schipperke Club of Southern California may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Clubs or any official thereof.
- 12. If, because of riots, civil disturbances or other acts beyond the control of these clubs, or management, it is impossible to open or complete the show, no refund of entry will be made.
- 13. Do not leave any dogs in closed vehicles.
- 14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half-hour prior to the start of the earliest conformation judging at the show.
- 15. Junior Handlers who win a third Novice Class after the closing of entries may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.
- 16. No alcohol is allowed on the grounds.
- 17. No practicing is allowed in the rings at any time.
- 18. Parents and/or guardians are responsible for the actions of their children.
- 19. By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present and agree not to hold the superintendent liable for any illness or injury.
- 20. By attending this event, you voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Jack Bradshaw Dog Shows, its owners, employees or volunteers liable for any illness or injury.
