SCHEDULE OF POINTS EFFECTIVE MAY 15, 2024 - SCHEDULE OF POINTS

For complete Conformation Championship requirements, see **Chapter 16** of the *Rules Applying to Dog Shows*.

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

VETERAN (For dogs or bitches seven (7) years of age and older)*

*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that "a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class."

AWARD OF MERIT

A Judge may, at his/her discretion, present an Award of Merit to those quality dogs he/she feels are worthy of final consideration in Best of Breed. Award of Merit winners will receive a three-streamer rosette in Belgian colors of black, yellow & red. The number of these awards is determined by the number of dogs actually competing in the ring (excluding Select Dog and Select Bitch):

3 - 7 = 1, 8 - 12 = 2, 13 - 17 = 3, 18 - 22 = 4, 23 or more = 5

ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw, 320 Maple Avenue, Torrance, CA 90503, by Noon, Wednesday, MAY 15, 2024, PDT. Fees should accompany entries. This club and/or its superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card **MUST BE MADE GOOD** by cash or money order **BEFORE** the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. **PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.**
4. During the hours of judging owners are to be on call and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, or of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club or of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7 a.m. to 8 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at www.akc.org.
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitor's setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club.
9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$4.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at this show.
11. Declination of Entries. Lompoc Valley Kennel Club, Santa Maria Kennel Club, Channel City Kennel Club, Ventura County Dog Fanciers Association and/or Schipperke Club of Southern California may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Recording and Event Service fees are to be collected by the Show-giving Club and paid to the American Kennel Club. These fees are included as part of the entry fees.
15. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one-half hour prior to the start of the earliest Conformation judging at the Show.
16. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
16. Parents and/or guardians are responsible for the actions of their children.
