## SCHEDULE OF POINTS EFFECTIVE MAY 15, 2024 - SCHEDULE OF POINTS

For complete Conformation Championship requirements, see Chapter 16 of the *Rules Applying to Dog Shows*.

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

For schedule of points corresponding to this dog show, please see breed heading.

**NOTICE:** An agent is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner of an exhibit to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications which are available online at akc.org.

**\*VETERAN DOG      \*VETERAN BITCH**

(For dogs or bitches seven (7) years of age and older)

Neutered Veteran Dogs or Spayed Veteran Bitches may be entered at this independent specialty show.

**BEST OF BREED COMPETITION**

The following categories of dogs may be entered in this competition: Dogs that are Champions of Record. Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of show where a dog completed the requirements for a championship according to the owners' records.

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES****STUD DOG AND BROOD BITCH - OFFERED AT FRIDAY SHOW ONLY**

**\*STUD DOG CLASS** - For Stud Dogs and two Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes. Or if a Champion of Record, in the Best of Breed Competition, but MUST be entered in the Stud Dog Class, the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

**\*BROOD BITCH CLASS** - Same as for the Stud Dog Class except substitute "Brood Bitch" for "Stud Dog" and "Produce" for "Get."

"Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

#### **PUPPY SWEEPSTAKES**

This Sweepstakes is open to all Schipperkes at least 6 months and under 18 months of age on the day of the show. Dogs who have completed their Championship are eligible to compete. The winner of each class will compete for Best in Puppy Sweepstakes and Best of Opposite Sex in Puppy Sweepstakes. All entries in Puppy Sweepstakes must also be entered in a regular class in this show. Entries shall be made at the same time on the same entry form used for the regular class. Indicate Puppy Sweepstakes and the appropriate sex and age in the space provided for Additional Classes.

The Following Age Division Classes Are Offered for Both Dogs and Bitches:

6 months & under 9 months ~ 9 months & under 12 months ~ 12 months & under 18 months

#### **VETERAN SWEEPSTAKES**

This Sweepstakes is open to all Schipperkes 7 years of age and over on the day of the show. Neutered dogs and spayed bitches may be entered in this class. The winner of each class will compete for Best in Veteran Sweepstakes and Best of Opposite Sex in Veteran Sweepstakes. Entries in Veteran Sweepstakes need not be entered in any other class at this show. Entries shall be made at the same time on the same entry form used for the regular classes. Indicate Veteran Sweepstakes and the appropriate sex and age in the space provided for Additional Classes.

The Following Age Division Classes Are Offered for Both Dogs and Bitches:

7 years and under 10 years ~ 10 years and under 12 years ~ 12 years and older

#### **DIVISION OF PRIZE MONEY FOR PUPPY & VETERAN SWEEPSTAKES**

All monies from entry fees will be divided as follows:

25% of monies received will be withheld by the club for SCSC expenses.

25% of monies received will be divided as follows: Best in Sweepstakes - 60%, Best of Opposite Sex - 40%

50% of monies received will be divided as follows:

Classes having four or more entries: First - 40%, Second - 30%, Third - 20%, Fourth - 10%

Classes having three entries: First - 50%, Second - 30%, Third - 20%

Classes having two entries: First - 60%, Second - 40%

Classes having one entry: First - 100%

### **JUNIOR SHOWMANSHIP COMPETITION**

**NOVICE CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Each dog handled in a regular Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Every dog entered for Junior Showmanship must be eligible to compete in AKC Dog Shows or Obedience Trials. Bitches in season are not eligible to compete.

Junior Handlers who win a third Novice Class, with competition present, after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent or Event Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes, which have been approved to date by AKC, write to the American Kennel Club, Show Plans, 5580 Centerview Dr., Suite 200, Raleigh, NC 27606.

Junior Handlers must include their AKC Junior Handler Identification number on the entry blank. You may obtain your number by calling the AKC (919)854-0195.

Each dog entered must be of the breed for which this show is held. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form. By signing the entry form certification is given that the Junior Showman does not now, and will not at any time act as an agent/handler for pay while continuing to compete in Junior Showmanship.

### **AKC NATIONAL OWNER HANDLER SERIES COMPETITION**

Must be owner-handled by a non-professional handler. Must be marked on the entry form by checking the selection box at the bottom of the entry form. Follows Best of Breed Judging. ### **AWARD OF MERIT**

A Judge may, at his/her discretion, present an Award of Merit to those quality dogs he/she feels are worthy of final consideration in Best of Breed. Award of Merit winners will receive a three-streamer rosette in Belgian colors of black, yellow & red. The number of these awards is determined by the number of dogs actually competing in the ring (excluding Select Dog and Select Bitch):

3 - 7 = 1    8 - 12 = 2    13 - 17 = 3    18 - 22 = 4    23 or more = 5

### ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw, 320 Maple Avenue, Torrance, CA 90503, by Noon, Wednesday January 8, 2025 PT. Fees should accompany entries. These clubs and their Superintendents assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agents of the owner. These clubs and its Superintendents assume no responsibility for entry by the owner or owners agents of a dog in a class in which the dog is not eligible to compete or for entering the same dog twice.
2. Returned checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check must be made good by cash or money order before the dog will be allowed in the ring.
3. Exhibitors' identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. Bring your identification tickets to the show.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly in order that the judge will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. It is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7:00 a.m. to 8:00 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the Superintendent's office should be advised at once in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at [www.akc.org](http://www.akc.org)
7. The club, its Superintendents and their employees will not be responsible for loss of or damage to any dog exhibited, whether as the result of accident or for any other cause and no responsibility is assumed for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises.
8. No crates, crates with carts, grooming tables, nor exercise pens will be allowed in the aisles. Setups, crates, equipment, etc. are to be in designated areas only, except as otherwise specifically authorized by the Show Chair, and will not be allowed in any other areas.
9. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of any entry fee for a duplicate entry. There will be a \$4.00 fee charged for cancellation of an entry prior to closing of entries.
10. There is no provision offered for un-entered dogs at this show.
11. Declination of Entries. The Schipperke Club of Southern California may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Clubs or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of these clubs, or management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half-hour prior to the start of the earliest conformation judging at the show.
15. Junior Handlers who win a third Novice Class after the closing of entries may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.
16. No alcohol is allowed on the grounds.
17. No practicing is allowed in the rings at any time.
18. Parents and/or guardians are responsible for the actions of their children.
