Household membership: \$25.00 (Open to two adult members residing in the same household, each eligible to vote and hold office. Each adult must be eighteen years of age and older, in good standing with the American Kennel Club and who subscribe to the purposes of this club.)

Associate membership: \$10.00 (Open to individuals who live outside of the club's area. Associate members may not vote, hold office or chair but may serve on a committee.)

Junior members: \$5.00 (Open to all children between the ages of 10 and 17. This shall be a non-voting and non-office holding membership.)
